

California Consumer Privacy Act (CCPA) Privacy Notice

Park Place Technologies and its global affiliates ("we," "our," or "us") value the privacy of our customers and clients. As part of our commitment to transparency and to comply with the California Consumer Privacy Act of 2018 (the "CCPA"), this Privacy Notice is designed to inform California residents of their rights regarding their personal information and how we collect, use, disclose, and protect that information.

- 1. **Right to Know**: You have the right to request information about the categories and specific pieces of personal information we have collected about you, as well as the purposes for which we have used your information.
- 2. **Right to Delete**: You have the right to request the deletion of your personal information, subject to certain exceptions.
- 3. **Right to Opt-Out of Sale**: You have the right to request that we do not sell your personal information to third parties. Note that we do not sell your personal information.
- 4. **Non-Discrimination**: You have the right to exercise your privacy rights without facing discriminatory treatment from us.
